### CONCLUSION

The Regina Police Service will celebrate its 125<sup>th</sup> Anniversary on July 19, 2017. This is a major milestone for our organization and will be highlighted with a number of celebrations throughout our community for community members and our members.

### BACKGROUND

On July 19, 1892, the Regina Police Service was established with the hiring of the first town Constable, James Williams. His duties included: Keeping the “toughs” under control, controlling roaming livestock, ringing the town bell 4 times daily, enforcing sanitation laws, impounding stray animals, preventing street obstructions, issuing dog tags, licensing transient traders, billiard rooms and refreshment houses.

On July 19, 2017, the Regina Police Service will celebrate its 125th Anniversary. Our Service has come a long way since the first town constable and is now a progressive organization that is highly respected both in our community and the larger policing community. This year, there will be a number of events to showcase this momentous occasion and thank our community for their support.

### DISCUSSION

The Regina Police Service is a proud organization and this 125th Anniversary is an opportunity to showcase the good work being done by our members every day in our community. We kicked off our 125<sup>th</sup> Anniversary celebration with an employee competition to design a new 125<sup>th</sup> Logo for use throughout the upcoming year. Five members of our Service submitted designs and these designs were carefully examined before selecting the winning design (left). The winning design was created by Les Parker, our Media Development Officer.



The Anniversary celebrations will include a refresh of our annual events using the 125<sup>th</sup> theme and incorporate two new events for employees and members of our community. All 125<sup>th</sup> Anniversary events are intended to make the community

aware of our long heritage and commitment to our community, our partners and our community safety. These events will highlight our appreciation for our employees' dedication to our service and the community support we receive.

The list of activities is extensive but there are two new events you will want to mark on your calendar. For these two events, we have partnered with the Regina Police Association and United Way Regina. On the actual 125<sup>th</sup> Anniversary, July 19<sup>th</sup>, there are plans to host a public celebration for our community followed by a private function for our members and their families. The public event is planned for Victoria Park over the lunch hour and local dignitaries, community members and our partners will be invited to attend.

The second event is a formal Charity Gala, in partnership with United Way Regina scheduled for October 14<sup>th</sup>. This is the first time we have hosted an event of this nature and magnitude and believe the partnership with United Way Regina will be effective in engaging our community's support and raising money for a committed community partner.

**CONCLUSION**

The Regina Police Service intends to raise awareness of the risks associated with using a cell phone while driving. Our goal is to reduce the incidents of distracted driving in the City of Regina. Distracted driving is the leading cause of traffic fatalities in the province. In 2015, 36 people were killed and 802 were injured in nearly 5,700 collisions where distracted driving was a factor.

SIGI has identified distracted driving as the traffic focus for the month of March. Throughout this month, the Regina Police Service will be partnering with Regina Transit and SIGI to initiate 'Operation Bus Cop'; an initiative where uniform police officers will periodically ride Regina Transit buses to enforce distracted driving laws. This approach enables police officers to ride Regina Transit buses in an effort to observe motorists who are using a cell phone while driving.

Members of the Traffic Safety Unit will start this initiative with a 'positive ticketing' campaign to raise awareness of the issue as well as alert Regina residents that police will be conducting this type of enforcement in the coming weeks.

**BACKGROUND**

The SIGI traffic focus for the month of March is Distracted Driving. As a result, the Regina Police Service is working proactively to address the issue of motorists who use their cell phones while driving. Although using a cell phone while driving has been illegal for several years, recent changes to the Traffic Safety Act, now make it illegal to use, hold, view or manipulate any type of cellphone while driving. The penalty for this offence is \$280. Second and subsequent offences that occur within a one-year period will also result in a 7-day vehicle impoundment.

A study from Virginia Tech Transportation Institute reported that drivers who are texting are 23 times more likely to be in a collision than those who don't. Talking on a cell phone makes the driver three – six times more likely to be in a collision.

Several Canadian police services have successfully run "Bus Cop" initiatives to help raise awareness to the dangers of distracted driving. The use of city buses will allow officers an excellent vantage point to observe motorists who choose to contravene distracted driving laws.

## DISCUSSION

The Regina Police Service will kick off “Operation Bus Cop” on February 22, 2017, through conventional and social media. This initial media campaign will also coincide with a positive ticketing initiative as well as a video release to media outlets that will attempt to bring awareness to the initiative. “Operation Bus Cop” will run from March 1-31, 2017. The initiative will also continue throughout the year periodically in an attempt to change the behaviour of motorists who choose to use their cell phones while operating a motor vehicle. To our knowledge, this will be the first “Operation Bus Cop” initiative in Saskatchewan.

Re: Warrant Strategy

### RECOMMENDATION

### CONCLUSION

The Regina Police Service has implemented a strategy to address outstanding and future warrants it will receive. The status of the strategy is being reported quarterly.

During this quarter, in addition to the normal course of their duties, front line patrol officers were assigned a minimum of three warrant files per month to investigate and execute. *Traffic Safety Act*, *City Bylaw* and *Provincial* statute warrants have also been executed through an internal call-back and appointment procedure that is expediting the warrant execution process.

The close monitoring of warrant assignments and the call-back process has increased the efficiency of the warrant strategy.

### BACKGROUND

On June 25, 2008, 4,152 people were wanted on 11,166 outstanding warrants. The breakdown was as follows:

- 3,840 Criminal Code
- 5,064 Provincial Statutes (Traffic Safety Act, Alcohol and Gaming, Enforcement of Maintenance Order, etc.)
- 2,262 Bylaw Offences (Parking, Dog, Cat, Noise, etc.)

A strategy was developed and implemented to arrest people with outstanding warrants, thereby reducing the number of outstanding warrants in the city. The strategy has been adjusted as circumstances have dictated and currently there are seven courses of action in place:

1. Each patrol Sergeant assigns 3 warrants per month to their respective patrol officers.
2. Front Desk Officers (Front Desk Warrant Strategy) conduct call-backs to wanted subjects in the *Traffic Safety Act*, *City Bylaw* and *Provincial* statute categories with information about the status of their warrant and solutions to deal with it.
3. Warrants issued for offences such as Break and Enter / Robbery / Theft of Auto are sent to specific units assigned with the Criminal Investigative Division to follow-up on.

4. The Service Centre officers have focused attention on identifying individuals living in the Heritage and North Central communities that have outstanding warrants and have taken proactive steps to locate and hold offenders accountable.
5. Warrants identified as historical warrants – those over 5 years old and the offence is not a personal injury offence - have been sent over to the Crown to be evaluated and withdrawn if appropriate.
6. Persons wanted on outstanding arrest warrants and believed to be residing outside of Regina and / or the Province of Saskatchewan have been identified and separated to account for outstanding arrest warrants and wanted persons with known residency in the City of Regina.
7. The investigative process following the request for a warrant has been streamlined to have the originating investigator locate and arrest the offender.

A change in legislation has had an effect on the number of arrest warrants dealt with by the Regina Police Service.

In 2012, the Province of Saskatchewan and Saskatchewan Government Insurance (SGI) implemented a change in how Traffic Court would deal with offenders who fail to appear in court on traffic citations. Any tickets involving voluntary fine amounts which were written after May 15, 2012, where the accused did not appear in court could be dealt with via default conviction. In these cases, the accused would be found guilty and the fine amount would be added to the cost of the person's license renewal.

In 2015, there was a steady increase in warrants of 6% by year end. As a result, a review of this strategy along with an audit of the Inactive Warrants was conducted to better understand the rise in warrants.

A physical audit and review of the Inactive Warrant Baskets was completed. On June 17, 2016, there were 1,595 warrants in the Inactive Warrant Baskets which included:

1. No Fixed Address - 18 Provincial Warrants
2. Out of Town Warrants - 371
3. No Fixed Address Criminal Code Warrants - 413
4. Out of Province Warrants - 675
5. Historical Warrants - 118

From this review, 81 warrants were moved back into the active baskets for assignment. This action has increased the amount of active warrants for assignment in the geographical area the wanted person resides in. If there was no new information for the warrant, it was returned to the basket it came from with a follow-up indicating the date and time of the review. An annual physical audit will be conducted to review and update these warrants. This audit is now complete and we will continue the call-backs as identified in the Front Desk Warrant Strategy.

The Proactive Policing Initiative brought together the Community Services Division (CSD) and Criminal Investigation Divisions (CID) to identified high profile targets with warrants. The district Staff Sergeants develop a Hot Sheet containing focus subjects, atoms, and addresses identified by our tactical analysts based on information and analysis of the prior week's incidents. The objective is to identify 3-5 names of focus subjects per week. This assessment and identification of weekly targets will occur from Wednesday to Wednesday each week. Members from CSD and CID use the information contained in the Hot Sheet to focus their Proactive work in the upcoming week.

These weekly Hot Sheets will be disseminated through NCO meetings and it is the Watch Commander's responsibility to ensure communication both down to the street level and up to the districts.

This strategy is an addition to the 3 warrants per officer every month. The Regina Police Service continues to review these processes in an effort to adopt new or innovative techniques that may further increase our efficiency in this area.

It is believed this review and audit will assist in reducing the number of wanted people and warrants in the City of Regina.

#### 2016 Analysis

An analysis of the fourth quarter of 2016 (Oct 1, 2016, to Dec 31, 2016) reveals the following:

At the start of this year, January 19, 2016, there were there were 2,708 people wanted on 3,450 outstanding warrants.

As of April 4, 2016, there were 2,814 people wanted on 3,547 warrants.

As of July 19, 2016, there were 2,715 people wanted on 3,387 warrants.

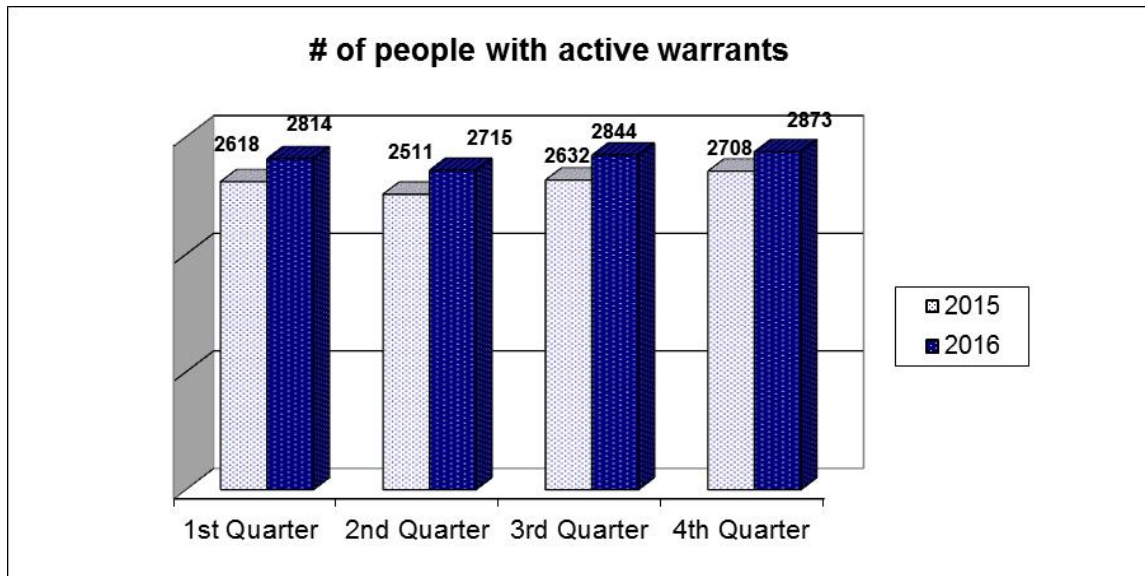
As of October 31, 2016, there were 2,844 people wanted on 3,524 warrants.

As of January 24, 2017, there were 2,873 people wanted on 3, 599 warrants.

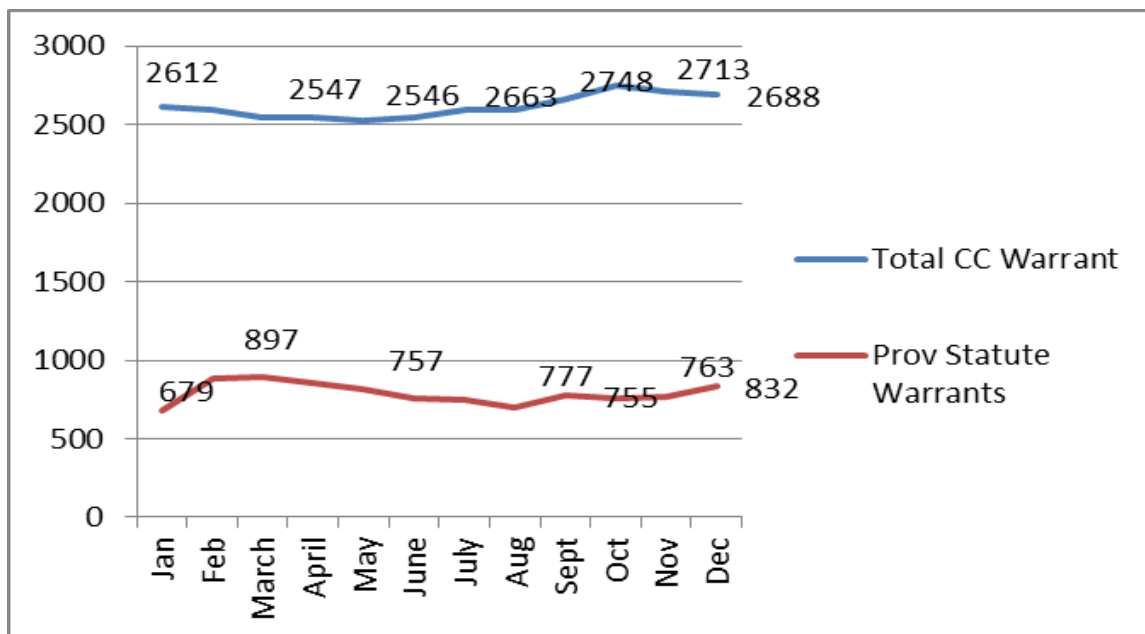
The breakdown indicates 2,688 Criminal Code warrants with 5,575 charges, 832 Provincial Statute warrants with 952 charges and 79 Municipal Bylaw warrants with 79 charges.

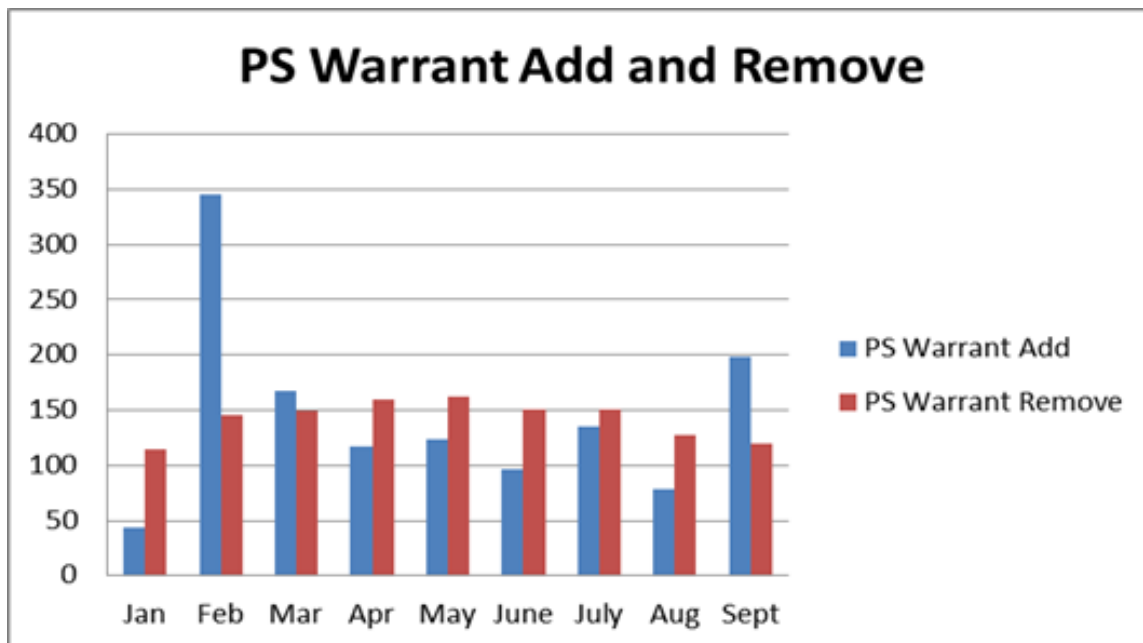
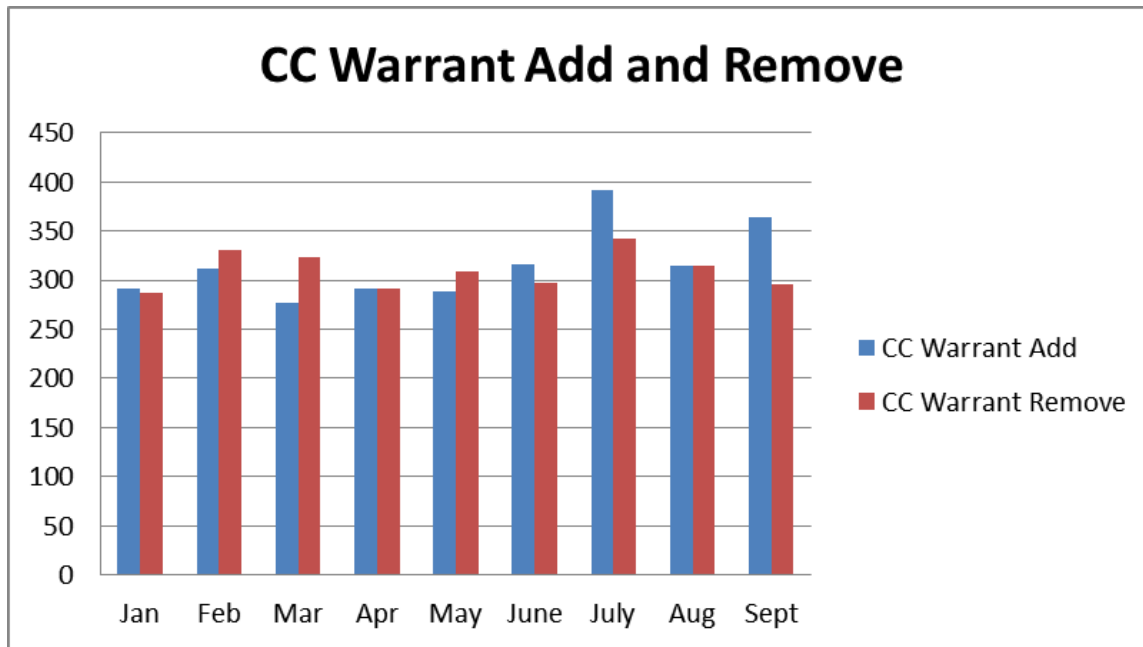
Total number of warrants 3,599, total charges 6606 (The difference in numbers indicates that a single wanted person may have multiple warrants for their arrest).

- The difference in people wanted has increased by 29, a 1 percent increase for this quarter.
- The difference in outstanding warrants is 75, a 2 percent increase for this quarter.

#### Strategic Analysis

Overall, since the introduction of this strategy in June 2008, where there were 4,152 subjects wanted on 11,166 outstanding warrants, the analysis shows the following:

June 2008 – 4,152 people wanted on 11,166 outstanding warrants

As of January 24, 2017, there were 2,873 people wanted on 3, 599 warrants.



- The difference in people wanted is 1,279, a 30.8 percent overall reduction.
- The difference in outstanding warrants is 7,567, a 67.7 percent overall reduction.

The implemented strategies have and will continue to impact the overall objective of managing and reducing the number of wanted people in the City of Regina.

**RECOMMENDATION**

**CONCLUSION**

The crime statistics for the month of January 2017 reflect a decrease in Crimes Against the Person of [-6.8%] compared to January 2016, while Crimes Against Property show a [-9.8%] decrease compared to January 2016. Crimes Against the Person and Crimes Against Property show a combined year-to-date decrease of [-9.2%].

**BACKGROUND**

Each month, reports providing statistics for the City of Regina are presented to the Board for their review and information. This report will provide statistics for the month of January 2017. The Communications Centre statistics are included showing the total calls for service.

**DISCUSSION**

Crimes Against Property reflect a decrease of [-84] reported incidents over 2016, for an overall year-to-date decrease of [-9.8%]. We have seen an increase of 29 reported incidents of Theft Under \$5000 for a 9.0% increase. There are [-39] less reported incidents of Mischief / Wilful Damage for a [-24.1%] decrease.

There was no change in Thefts of Auto rates in our year-to-date statistics. The Regina Police Service in conjunction with its partners in the Stolen Auto Strategy continues to pay constant attention to this issue.

Crimes Against the Person reflect a year-to-date decrease of [-14] incidents over January 2016 for a [-6.8%] decrease. There were 26 reported Robberies in January for a year-to-date increase of 4 incidents or an increase of 18.2%.

Overall the Regina Police Service received [-98] fewer reported incidents of Crimes Against the Person and Crimes Against Property combined in 2017 over 2016 for a [-9.2%] decrease.

There were a total of 6,492 dispatched Calls for Service in January for a year-to-date decrease of [-2.5%] and Alarm Calls for Service show a year-to-date decrease of [-0.9%].

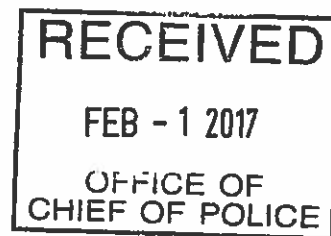

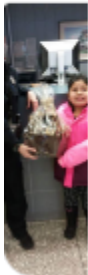

This may happen alot (I hope it does) but it was such a kind interaction I just wanted to say GREAT JOB!! (the officer was in car 23) Thank you!

Just wanting to say thank you to the three officers that helped my grandson out yesterday. I didn't get to meet the officer that picked up my grandson [REDACTED] after trying to run away but whatever he said to him during that time seems to left a good impression on him. I didn't even get the names of the officers that came to our home and spoke with [REDACTED]s mom and myself but they were terrific. Today we are arranging some much needed counselling for [REDACTED] and ourselves so we can all work out this mid teen crisis. He is an awesome kid without all the peer pressure and bad influences of friends bringing drugs and alcohol to school. We will do anything to help steer him on the right track. You all do so much for our city and the officers yesterday were so in tune with the struggles that kids face today it was awesome. Thank you from the bottom of my heart and I hope soon that [REDACTED] will thank you too.

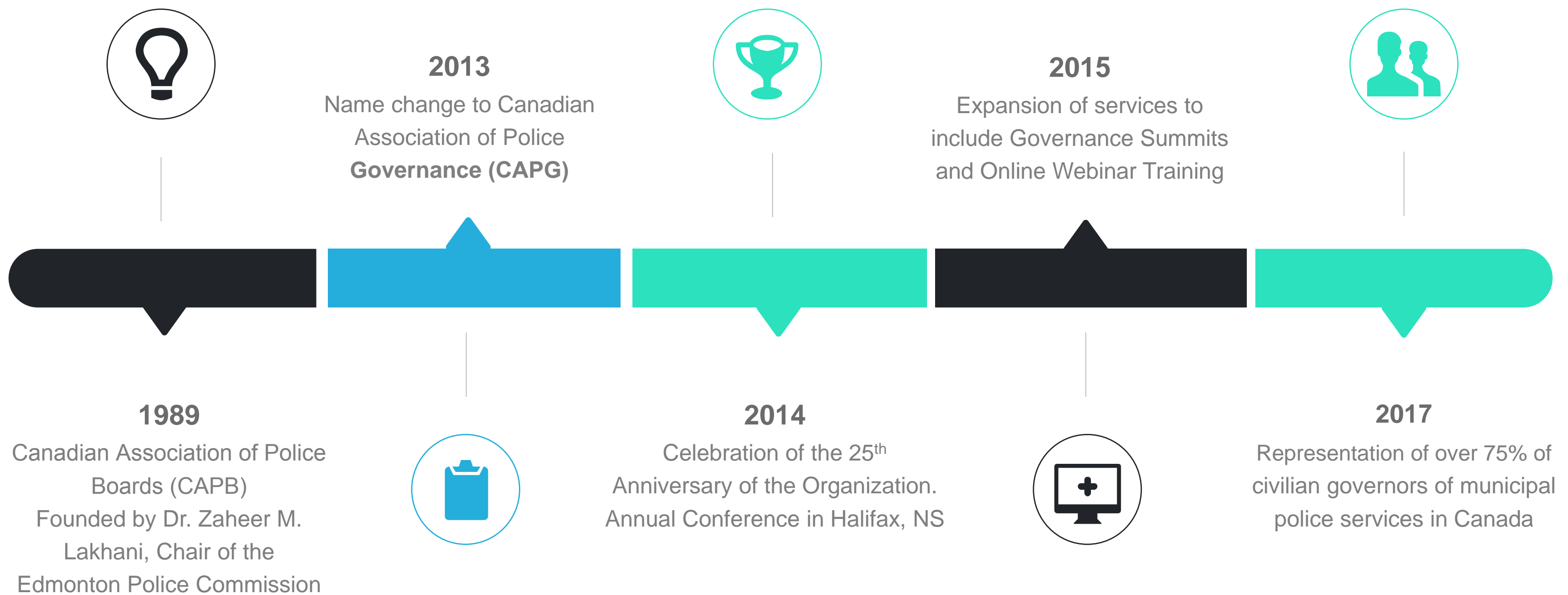

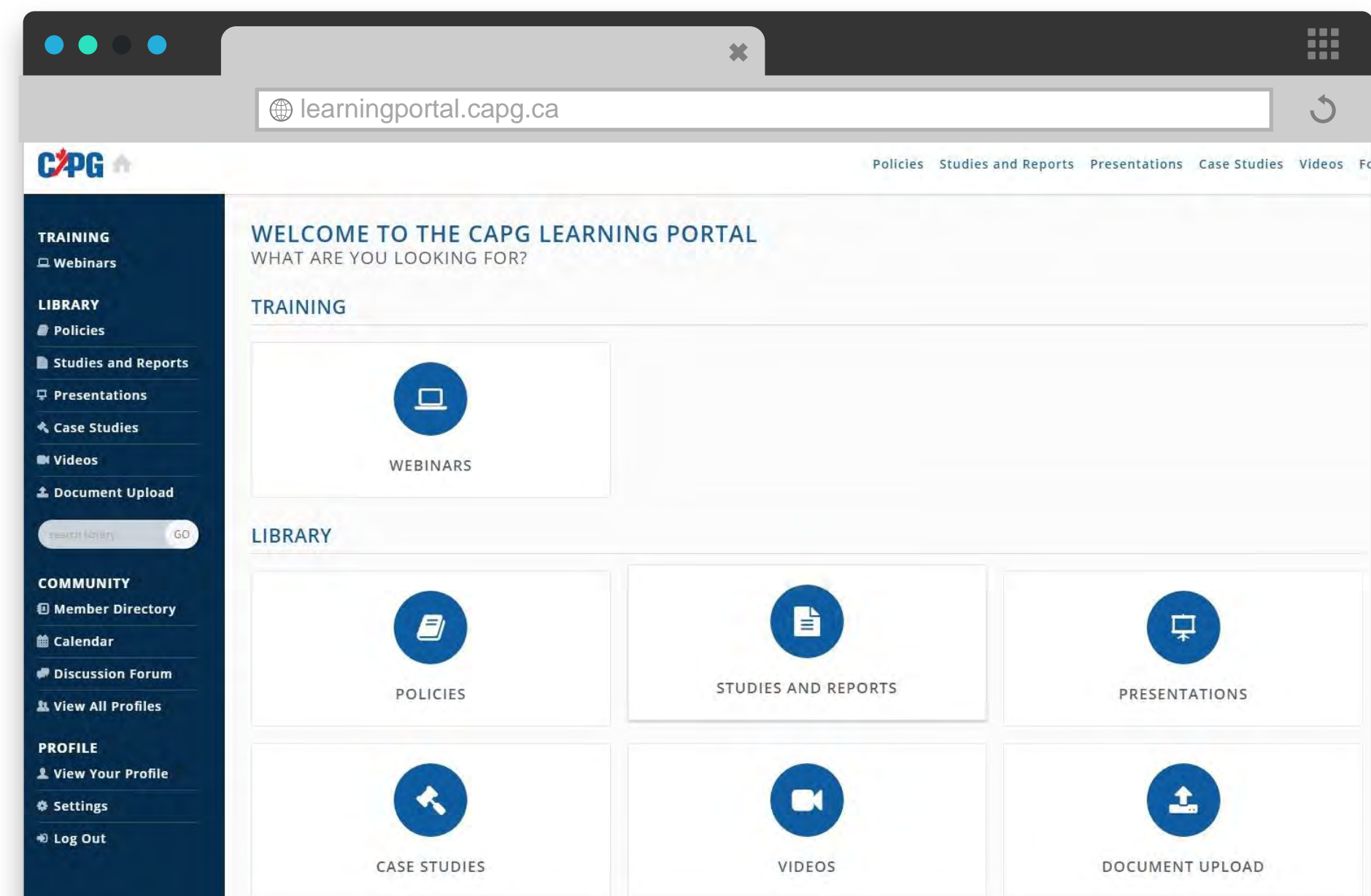
